Segment I Course Provisions

1. Georgetown Driving School will provide a minimum of 24 hours of classroom instruction and a minimum of six (6) hours of behind-the-wheel (BTW) instruction, and 4 hours of observation time. Classroom time will take place over 3 weeks.

2. Georgetown Driving School will conduct the behind-the-wheel instruction in a dual controlled automobile, fully insured, covering each student enrolled in the program. BTW instruction will take place no later than 3 weeks after classroom instruction has been completed.

3. Driving tasks to be achieved:

- Left turns
- Right turns
- U-turns
- 3-point (Y) turns
- Backing in and out of driveways
- Backing in a straight line
- Parallel Parking
- Angle and perpendicular parking
- Lane changing
- Entering and Exiting highways
- Turning on and off multiple-lane streets
- Varying levels of traffic and driving environments

4. Students are required to maintain a 70% average on all assignments and tests. Students must also achieve 70% correct answers on the Final State Exam (80 Questions).

5. Upon completion of the course, the student will be issued a "MICHIGAN DRIVER EDUCATION CERTIFICATE OF COMPLETION" attesting to his/her completion of the requirements for the certificate.

Terms

The parent of legal guardian authorizes the student to take part in the program on the basis that the student meets the physical requirements specified by the law for issuance of a motor vehicle operator's license. The student must be at least 14 years/8 months of age by the beginning of class (verification by birth certificate required).

The parent of legal guardian agrees to pay the amount of \$400.00. Student text and materials will be provided for the student to use. If the student text is not returned in proper condition, a \$10.00 fee will be charged. The full amount is due no later than the first day of class. There is a \$25.00 charge for all returned checks. Should gas prices reach \$4/gallon, a fuel surcharge of \$10.00 will be added. Georgetown Driving School assumes all liabilities contained within this agreement. In case of instructor emergency/illness, Georgetown Driving School reserves the right to cancel class during the regularly scheduled time and reschedule class & driving times as needed.

Refund/Make-up Policy

If for any reason you decide to withdraw from the course before it ends, your refund would be based on the following:

- A. If withdrawal is after any driving has taken place, no refund will be given.
- B. No refund will be given until all supplies are returned to the instructor.
- C. \$100.00 of the total amount due will be considered a deposit and is non-refundable.
- D. One absence will be permitted, with a written permission slip signed by the parent or legal guardian. All absences must be made up during the next available class session. All missed drives must be made up during the current class session.
