Segment 2 Course Provisions

1. Georgetown Driving School will provide six (6) hours of classroom instruction.
2. Georgetown Driving School will supply all materials for the class.
3. The student will be required to pass a 20 question state exam with a 70% or better completion.
4. Upon completion of the course, the student will be issued a "MICHIGAN DRIVER EDUCATION CERTIFICATE OF COMPLETION" attesting to his/her completion of the requirements that the Michigan Department of State has set for Segment 2 of the graduated licensing program.

Terms

The parent of legal guardian authorizes the student to take part in the program on the basis that the student meets the physical requirements specified by the law for issuance of a motor vehicle operator's license. For a student to participate in segment 2, verification must be received that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent or guardian (or parent designee) on a *level 1 license, which has been held for not less than 3 continuous months*. The parent/legal guardian agrees to pay the fee prior to the second night of class of \$40.00. There is a \$25.00 charge for all returned checks. Along with driving comes responsibility. Behavior problems will result in an automatic dismissal with no refund. Georgetown Driving School assumes all liabilities contained within this agreement.

Refund Policy:

If for any reason you decide to withdraw from the course or not take the course, there will be no refund.
